State Fund knew more layoffs were coming

Plan puts recently relocated employees at risk

Local 1000 member negotiators are meeting with State Fund management this week in response to the department's layoff proposal and the impact of the agreement negotiated earlier

this year.

"Our contract guarantees certain rights for members," said Margarita Maldonado, vice president for bargaining. "Our goal is to get an understanding of State Fund's monetary constraints and offer solutions that protect members and keep them employed."

The latest negotiations come just months after State Fund put their reorganization plan in place, forcing hundreds of Local 1000 members to relocate hundreds of miles from their homes or leave state service. Hundreds of additional employees are scheduled to relocate next year, adding to workplace instability.

"Local 1000 is outraged that employees were relocated in September without advance notice that a decision had been made to lay them off," said Maldonado. "Program Technicians relocated from Burbank to Fresno on September 27-then State Fund announced layoffs nine days later."

Maldonado says this kind of corporate behavior is what one sees on Wall Street—you don't expect it from a state agency.

Actual layoff negotiations will occur once State Fund submits a layoff plan to the Department of Personnel Administration (DPA). State Fund plans to submit the plan and receive approval sometime in December. State Fund says the earliest employees can expect layoffs to begin is April.

During negotiations last spring around State Fund's reorganization plan, Local 1000 member negotiators asserted State Fund would not meet its attrition goals without offering a severance package.

"We brought in retirement experts and conducted a complex costing analysis," Maldonado said. "We demonstrated how State Fund could accelerate attrition and save the state money. If our proposals had been accepted, some of the problems State Fund is facing today would have been avoided."

Process, options discussed at worksite meetings

Local 1000 members at the California Department of Corrections and Rehabilitation (CDCR) worksites up and down the state are attending meetings to learn more about their options as CDCR begins its multi-year realignment process.

"We are sharing with them the details of a 46-point agreement we reached with CDCR that provides more opportunities and more protections for CDCR employees," said Margarita Maldonado, Local 1000 vice president for bargaining. "It's a much more transparent process."

A team of 40 Local 1000 member leaders and staff will hold meetings for members at or near every CDCR worksite. They're distributing an eight-page "CDCR Realignment Guide" that explains three key elements: voluntary transfers, the SROA/layoff process and involuntary transfers. A schedule of meetings - updated on an ongoing basis – is available online at seiu1000.org/campaigns/cdcr

"Our members are thanking us for the work we do and for answering their questions," said Rionna Jones, a CDCR pharmacy technician. "We're also getting support from CDCR in promoting attendance at the meetings."
