The high cost of housing is a daily frustration for many of our members. Our members have boldly stepped forward to provide leadership on the high cost of housing in Sacramento, where rents rose faster than anywhere else in the country in 2017.

On April 16, our members, working in coalition with other labor unions and community organizations, called on the Sacramento City Council to create real solutions for tenants facing unreasonable rental costs and unjust evictions.
