

# EDD PI Conversion Win

## More EDD workers gain full-time status

Persistent pressure from Local 1000 paid off for 125 Permanent Intermittent workers at the EDD's Unemployment Insurance branch who will be converted to full-time status on May 1. Our members have been vigilant in demanding the department comply with our contract and recognize longtime EDD employees with the benefits and career advancement opportunities that come with full-time status.

Our contract limits the percentage of permanent intermittent (PI) employees to 20 percent, but EDD's Unemployment Insurance Branch has been in violation of that limit, with a PI ratio around 31 percent, for the past year. In comparison, the Disability Insurance Branch has a PI ratio of only 10 percent because of pressure from Local 1000.

"We have been fighting tirelessly," said Bargaining Unit 1 Chair Brenda Modkins. "These conversions are a result of our pushing for compliance."

Local 1000 has waged an ongoing fight to convert PI workers to full-time status throughout EDD, after the department hired hundreds of new employees last year to deal with chronic backlogs.

Local 1000's Purpose Statement says: "The purpose of Local 1000 is to have the power necessary to give our members—and all Californians—the opportunity to

Local 1000 President Yvonne R. Walker said that our members in the agencies under CalEPA, including the Air Resources Board (ARB), the Department of Pesticide Regulation (DPR), the Department of Resources Recycling and Recovery, (CalRecycle), the Department of Toxic Substances Control (DTSC), the Office of Environmental Health Hazard Assessment (OEHHA) and the State Water Resources Control Board (SWRCB) as well

as members in the Department of Fish and Wildlife, Department of Forestry and Fire Protection, the California State Parks and other agencies also work to ensure that our families live in a safe environment.

"Our work for environmental justice is really an extension of the fight for economic and social justice in our communities," Walker said. "I applaud our members who work every day for environmental justice as well as those of who volunteer in our communities in their free time."
