# The Union proposes the following:

This Agreement is a Side Letter to the current Memorandum of Understanding (MOU) effective July 1, 2023 through June 30, 2026 between Service Employees International Union, Local 1000 (Union) and the State of California (State).

With respect to the Unit 1 Analyst Classification and Consolidation, the Union and the State do hereby agree as follows:

- 1. MAPPING AND PLACEMENT
  - A. Classification titles [See appendix for Full Mapping]:
    - Analyst IAnalyst IIAnalyst IIIAnalyst IV
  - B. No employee shall be demoted or lose wages because of this classification consolidation.

# 2. WORKING TITLES/SPECIALIZATION

A. Employees in the classification consolidation may, consistent with departmental rules and policies, use working titles, including specialized experience and expertise, in official business correspondence as well as for career and professional development.

#### 3. PROBATION PERIODS

A. All employees currently on probation shall retain their current probationary periods.

# 4. ANNIVERSARY DATES

- A. Employees shall maintain their original anniversary date.
- B. All employees defined above shall have no alterations or changes made to their eligibility timelines for their next Merit Salary Adjustment.

#### 5. JOINT LABOR MANAGEMENT COMMITTEE

- A. The Union and the State agree to form a Joint Labor Management Committee (JLMC) to discuss consolidation efforts, including, but not limited to implementation and future consolidation series. The JLMC shall meet at least once per quarter. Additional meetings can be scheduled upon agreement with both parties. The JLMC shall abide by Article 5.10 of the MOU. Topics of discussion shall include, but are not limited to:
  - 1. Implementation of the generalist consolidation.
  - 2. Expanded scope of classifications under a future phase of the generalist consolidation.

3. Mapping of expanded scope of classifications under a future phase of the generalist consolidation.

### 6. <u>LIMITED TERM DESIGNATED EMPLOYEES</u>

- A. The parties agree that this Side Letter Agreement does not change, alter, or restrict the rights of Limited Term employees, or the ability for departments to utilize Limited Term employees.
- B. The parties agree that no Limited Term employees shall be terminated solely because of this reclassification and consolidation.

### 7. <u>LEAD RESPONSIBILITIES</u>

A. The parties agree that this reclassification and consolidation shall not impact the Unit 1 Lead Responsibilities, outlined in Section 14.13.1 of the MOU.

# THE PARTIES FURTHER AGREE:

This agreement may be signed by e-signature and in counterparts, which, when all necessary signatures are obtained, shall have the same force and effect as though all signatures were executed on one document.
