You pay no money down for these policies, and most premiums are automatically deducted from your paycheck. Coverage can't get any easier!

Insurance Coverage

Group Rate Insurance – Compare and Save.

- **Group Life Insurance[§]** – We have multiple life insurance programs that can help protect your family's financial security for up to \$1,000,000! All have exclusive member rates with the convenience of payroll deduction. You can lock in your rates for 10 years with Group 10-Year Level Term Life or choose a guaranteed issue coverage option with NO health questions for Group TermPLUS if applying in your first seven months of employment. Retired members can also specifically choose guaranteed issue Group Level Term Retiree Life Insurance coverage of up to \$20,000 provided that the retired member is under age 81. Some insurance provide you coverage from a covered accident. With any of CSEA's sponsored life insurance, you can rest assured knowing you have helped protect your loved ones.
- **Long Term Disability Insurance[§]** – Severe illness or injury can strike anyone. What would happen if you were disabled and stopped receiving your paycheck? Help protect yourself and your family's future by applying for disability insurance. Receive monthly benefits up to \$6,000, based on monthly income, with either a 2 year or 5 year policy. You can also collect up to \$5,000 with the included Accidental Death and Dismemberment (AD&D) benefit - on top of any other disability benefit - for death and certain physical injuries

caused by a covered accident.

- **Group Accidental Death and Dismemberment Insurance[§]** – The possibility of a sudden accidental death is frightening, but dealing with the financial aspects don't have to be.
